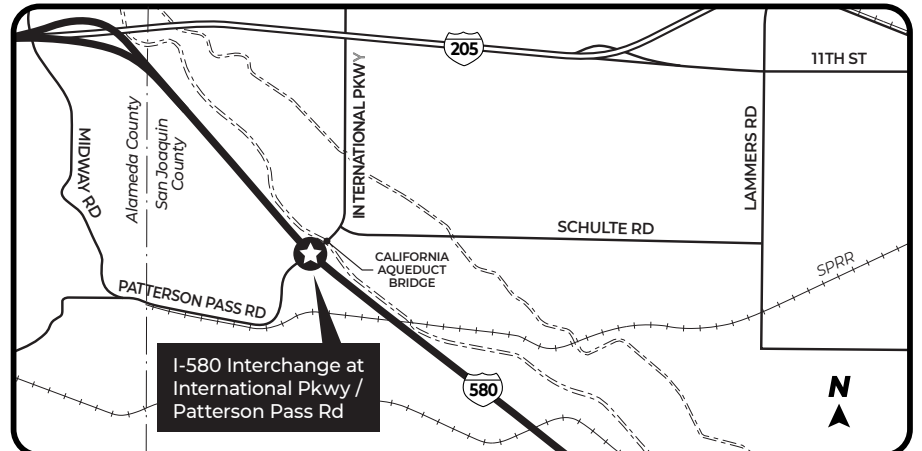
Notice of Intent to Adopt a Mitigated Negative Declaration (Study Results Available) and Opportunity for a Public Hearing

I-580 and International Parkway/Patterson Pass Road Interchange

PUBLIC COMMENT PERIOD

Comments will be accepted from July 1 to July 30, 2020.

If there are no major comments or requests for a public hearing, Caltrans will proceed with the project's design.



WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans), in cooperation with the city of Tracy, proposes to improve the existing compact diamond interchange at Interstate 580 (I-580) and International Parkway/Patterson Pass Road (post miles 12.6 to 14.3). Proposed improvements are needed due to increased traffic demands from existing commercial development and planned future growth in San Joaquin County. The proposed project will reduce congestion resulting from ongoing and planned development of the Cordes Ranch Specific Plan and improve local traffic circulation. The Initial Study with Proposed Mitigated Negative Declaration identifies two alternatives (Build and No-Build), their associated environmental impacts, and subsequent mitigation measures established to minimize potential impacts.

WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment, and our studies show that it will not significantly affect the quality of the environment. This notice is to inform the public that an Initial Study with Proposed Mitigated Negative Declaration has been prepared for the project and is now available for review and comments. This notice also offers the opportunity to request a public hearing. The project is not considered a Project of Air Quality Concern regarding particulate matter (PM10 and PM2.5) as defined in 40 CFR 93.123(b)(1). A detailed PM10 and PM2.5 hot-spot analysis was not completed because the Clean Air Act and 40 CFR 93.116 requirements are met without an explicit hot-spot analysis.
